WHERE DO I FIND THEM?

- The **NEW Discharge Summaries** tab

WHAT CAN I EXPECT TO SEE? TYPICALLY...

- Reason for hospitalization
- Discharge disposition
- Diagnoses, allergies, medications, results
- Patient & family instructions
- Hospital course/progress notes

WHEN WILL I SEE THEM?

- Available after treating provider signs off
- Updated if an attending provider signs off

CAN I PRINT THEM?

- Yes! You can print them by clicking the "Print" link inside a discharge summary report.

Don't forget the Documents Tab: You can access Discharge CoC documents from Lifespan Hospitals (Rhode Island Hospital, The Miriam Hospital, Newport Hospital & Hasbro Children's Hospital), and other Medical Record Summaries/Continuity of Care Documents.
